Each band will perform one set not to exceed twenty minutes.





## **Eligibility Requirements:**

- Each "band" must have at least 2 people playing instruments.
- Band can be any size.
- This event is not limited to any musical genre.
- Actual performance must include at least one original song
- A first place winner is ineligible to compete for the following two years.
- Instruments on stage will be provided as follows:

Full drum kit

Two guitar amplifiers

One bass amplifier

One keyboard stand

Vocal mics as needed

All performers must use the instruments provided.

Exceptions are keyboards that are small enough to be carried on and off by one person.

Drummers may use their own snare drum and/or cymbals if desired.

Each application must be received no later than March 30, 2018, an application form, a \$50.00 application fee, and a music sample.

Sample must be no longer than 5 minutes and must be submitted electronically along with whatever bios and press are available. Samples must be sound only, in either mp3 or mp4 format. Videos will not be accepted

Samples will not be returned.

Finalists will be notified no later than April 12, 2018
